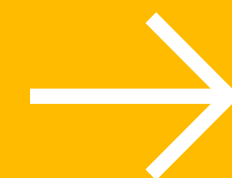


HUMANITARIAN SOCIAL JUSTICE



WELCOME TO HSJ

OUR BACKGROUND

The legal experience of acting lawyers, with an academic bias, in human and social rights, as well as the sponsorship of free legal assistance for more than 20 years, led to the interest of following the cases of human trafficking, domestic violence, exploitation and child sexual abuse in South Florida in the last 3 years, which have even been intensified during the pandemic, worsening the outline of the humanitarian crisis, not only in south Florida but in the whole world as well.



IDENTIFIED DEMAND

There is a lack of legal assistance to vulnerable people in Brazil and in the world; especially for migrants who face cultural, language and financial difficulties in addition to the lack of knowledge of the domestic legislation. In spite of the existence of institutions dedicated to the humane care of the vulnerable people with food, shelter and integration, most of them do not assist with the minimum civil rights, not even with information so that there are better choices in guaranteeing their human dignity, citizenship rights, housing, police protection and others more.



PURPOSE

1

Bring together lawyers and people from the legal professions, paralegals, law students and volunteers to provide assistance to people who are discriminated against and in situations of vulnerability, such as in poverty, refugees, persecuted and in need of legal assistance;

Provide legal assistance with agility and mobilize humanitarian means, through lawyers who are able to promote justice with efficiency, competence and necessary dedication with the competent bodies;



PURPOSE

Search for all appropriate national and international collaborations to enable and fulfill the mission in all parts of the world;

Promotion of established rights, construction of new rights and free legal advice of supplementary interest;

5

Promotion of ethics, peace, citizenship, human rights, democracy and other universal values;

6

Studies and research, alternative technological development, production and dissemination of information and technical/scientific knowledge concerning the activities mentioned in this presentation.

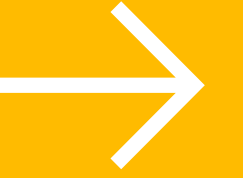

HOW WE WORK

1

Presentation and dissemination of HSJ to civil society and government agencies;

2

Formalization of terms of cooperation between governmental and non-governmental institutions;

3

Formation of a legal body of lawyers of different nationalities so that HSJ can act anywhere in the world;

4

Provision of consultancy and legal assistance to vulnerable people around the world through its local representatives in Brazil and other countries;

5

Form an alliance in search of sponsorship with civil society, the creation of a private fund with the objective of remunerating the active legal body, promoting the appreciation of law in the world and promoting justice without borders;



HOW WE WORK

6

To spread the possibilities of formation of the fund through the incorporation of new members, donations from civil society and agreements, attorney's fees to prevailing party, sale of donated souvenirs, in addition to the promotion of paid events and courses;

7

Promotion of studies and research, development of alternative technologies, production and dissemination of technical and scientific information and knowledge concerning the activities of HSJ.
